CHANGES IN LOCAL GOVERNMENT AREAS**

**The Highland and Strathclyde Regions (Duror and Glen Etive
and Glencoe) Boundaries Order 1977**

<i>Made - - - -</i>	<i>7th January 1977</i>
<i>Laid before Parliament</i>	<i>17th January 1977</i>
<i>Coming into Operation</i>	<i>1st April 1977</i>

In exercise of the powers conferred on me by section 17(2) of the Local Government (Scotland) Act 1973(a) to give effect to proposals made by the Local Government Boundary Commission for Scotland under section 14(2) of the Act, and of all other powers enabling me in that behalf, I hereby make the following order:—

Title and commencement

1. This order may be cited as the Highland and Strathclyde Regions (Duror and Glen Etive and Glencoe) Boundaries Order 1977 and shall come into operation on 1st April 1977.

Interpretation

2. The Interpretation Act 1889(b) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

Application of Regulations

3. The Local Government Area Changes (Scotland) Regulations 1977(c) shall apply for the purposes of this order to such extent as may be required to implement the area changes effected by article 4 of this order.

Area changes

4. The areas comprising those parts of the Argyll and Bute District and the Strathclyde Region and situated—

- (1) in the vicinity of the village of Duror and including Eilean Balnagowan described in Part 1 of the Schedule to this order and delineated and shown cross-hatched on map 1 annexed and signed as relative hereto; and

(2) at Glen Etive and part of Glencoe described in Part 2 of the Schedule to this order and delineated and shown hatched on the said map 1; shall be transferred to the Lochaber District and the Highland Region.

Article 4

SCHEDULE

TRANSFERRED AREAS

PART 1

The area transferred by article 4(1) of this order is bounded as follows:—

commencing at the point on the southern boundary of the Highland Region where the Allt Coire Dhuibh burn meets the River Duror; thence generally southwards along the said burn to its source; thence southwestwards in a straight line to the summit of Fraochaidh; thence generally southwestwards following the field boundary from that summit to its junction with the field boundary west of Beinn Mhic na Céisich; thence following the watershed between the area draining into the Salachan Burn and the area draining into An Iola to the summit of Meall Bàn; thence generally northwestwards in a straight line to the source, at NG ref NM 99195010, of the unnamed burn draining into Lochan Blàr nan Lochan; thence following the said burn to the said loch; thence generally northwards through the said loch to the outfall of the Eas nan Richagan burn; thence generally northwestwards following the said burn to its confluence with the unnamed burn at NG ref NM 97435053; thence northwestwards in a straight line to the summit of Beinn Sgluich; thence generally northwestwards in a straight line to the source of the unnamed burn at NG ref NM 96425195; thence generally northwestwards along the said burn to MLWS; thence along the Highland Region boundary generally north-eastwards and southeastwards to the point of commencement;

and the new portion of the boundary between the Argyll and Bute District and the Strathclyde Region and the Lochaber District and the Highland Region is delineated on maps 2 to 5 annexed and signed as relative to this order.

There shall be included in the area to be transferred Eilean Balnagowan in Loch Linnhe.

PART 2

The area transferred by article 4(2) of this order is bounded as follows:—

commencing at the point on the northern boundary of the Strathclyde Region where it meets the unnamed burn at NG ref NN 38935017; thence generally southwestwards and northwestwards along the said burn to its source at NG ref NN 37885008; thence southwestwards in a straight line to the unnamed tributary of the Abhain Bà

at NG ref NN 37074992; thence generally southwestwards and northwestwards along the said tributary to its confluence with the burn flowing out of the westernmost Dubh Lochain; thence generally southwards along the said burn to its outfall from the said loch; thence generally southwards following the western shore of the loch to the mouth of the unnamed burn at NG ref NN 34034839; thence generally southwestwards along the said burn to its source at NG ref NN 32944762; thence southwestwards in a straight line to the summit of Glas Bheinn; thence westwards in a straight line to the A82(T) road at NG ref NN 31394723; thence generally westwards following the watershed between the area draining to Loch Bà and the area draining to Loch Tulla through the summits of Meall Beag, Beinn Toaig, Stob a' Choire Odhair, Stob Ghabhar, Stob a' Bhruaich Léith and Meall Odhar to the summit of Meall Tarsuinn; thence generally southwestwards along the watershed between the area draining into the River Etive and the area draining into the River Kinglass through the summits of Stob Coir' an Albannaich, Glas Bheinn Mhór, Meall nan Tri Tighearnan, and Stob Coire Dheirg to the southeastern summit of Ben Starav at NG ref NN 12844249; thence southwestwards in a straight line to the source of the most northerly tributary of the Allt Coire na Làrach at NG ref NN 12434241; thence generally southwestwards along the said tributary to its confluence with the said burn; thence generally westwards along the said burn to MLWS at NG ref NN 09684168; thence generally northeastwards, westwards and southwestwards along MLWS to the mouth of the unnamed burn at NG ref NN 09624249; thence generally northwestwards along the said burn to its source at NG ref NN08854315; thence northwards in a straight line to the summit of Beinn Trilleachan; thence generally northeastwards along the watershed between the area draining into Loch Etive and the area draining into the River Ure to the source of the unnamed burn at NG ref NN 09684544; thence generally northwards along the said burn to its confluence with the Allt Criche; thence generally northwards along the Allt Criche to its confluence with the Allt a' Bhoirain; thence generally northwestwards along the Allt a' Bhoirain to its confluence with the unnamed burn south of Creagan Socach; thence generally northwards along the said burn to its outfall from Lochan na Fola; thence generally northeastwards through the loch to the mouth of the unnamed burn on its eastern bank; thence generally eastwards along the said burn to its source at NG ref NN 09694834; thence generally northeastwards along the watershed between the area draining into the River Creran and the area draining into the River Etive to meet the existing boundary of the Strathclyde Region on the River Creran at NG ref NN 11075064; thence following the existing regional boundary generally eastwards and southwards to the point of commencement;

and the new portion of the boundary between the Argyll and Bute District and the Strathclyde Region and the Lochaber District and the Highland Region is delineated on maps 6 to 18 annexed and signed as relative to this order.

Note:—In the above descriptions a reference to a river or burn shall, where the context so admits, be construed as a reference to the centre line thereof.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order transfers from the Argyll and Bute District and the Strathclyde Region to the Lochaber District and the Highland Region (1) an area lying to the south and west of the village of Duror and (2) Glen Etive and part of Glencoe. The effect of this is that the whole village of Duror, and the whole of Glencoe and Glen Etive now come within the Highland Region.
