**Boundaries Order 1977**

In exercise of the powers conferred on me by section 17(2) of the Local Government (Scotland) Act 1973(a) to give effect to proposals made by the Local Government Boundary Commission for Scotland under section 14(2) of the Act, and of all other powers enabling me in that behalf, I hereby make the following order:—

*Title and commencement*

1. This order may be cited as the East Kilbride and Hamilton Districts (Sandford) Boundaries Order 1977 and shall come into operation on 1st April 1977.

*Interpretation*

2. The Interpretation Act 1889(b) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.

*Application of regulations*

3. The Local Government Area Changes (Scotland) Regulations 1977(c) shall apply for the purposes of this order to such extent as may be required to implement the area change effected by article 4 of this order.

*Area change*

4. That part of the Hamilton District containing part of the Village of Sandford described in the Schedule to this order and delineated and hatched on the map signed as relative to this order shall be transferred to the East Kilbride District.

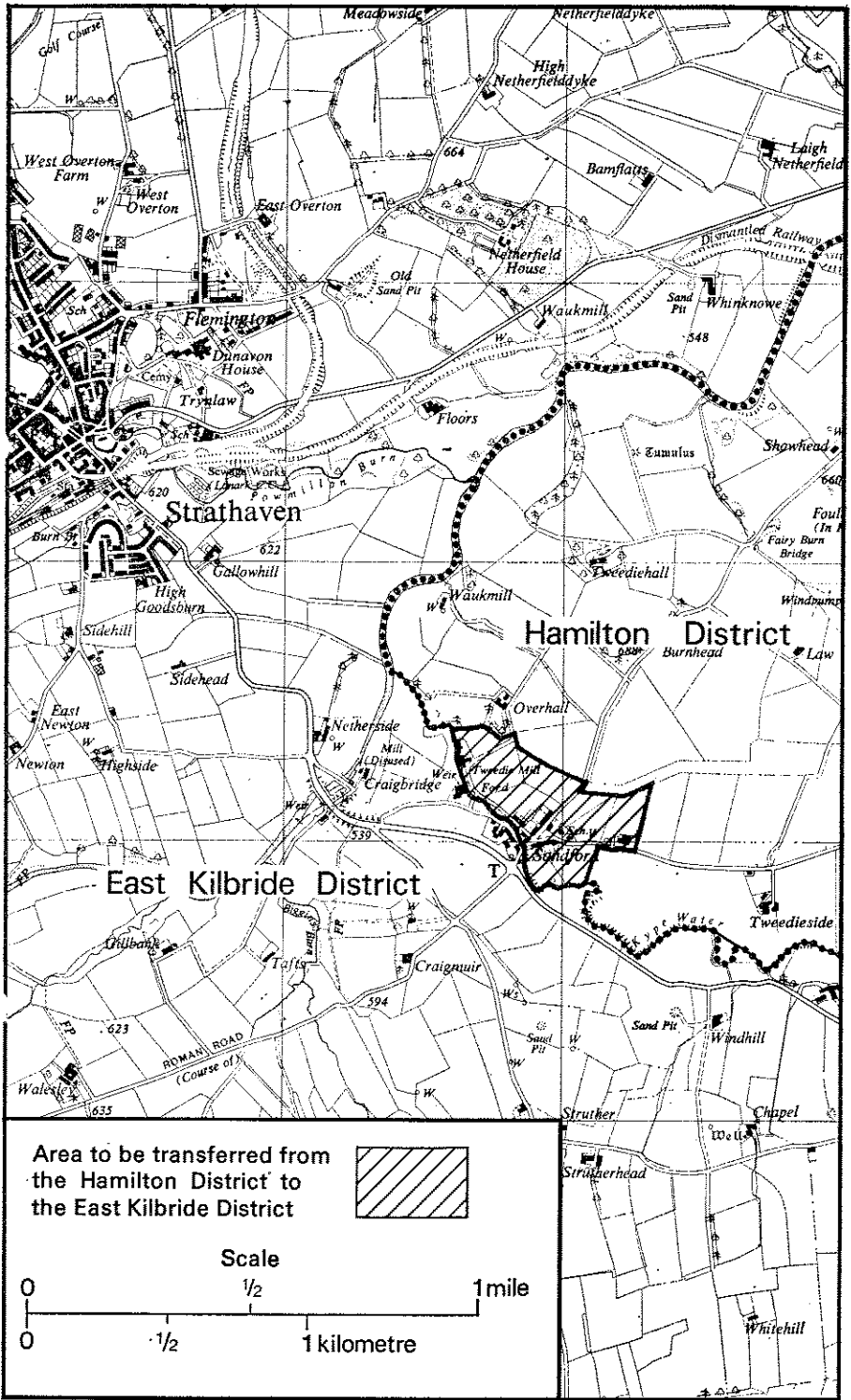

**SCHEDULE**  
**TRANSFERRED AREA**

The area transferred by this order is bounded as follows:—

commencing on the eastern boundary of East Kilbride District at NG ref NS 7208542845 as shown on Ordnance Survey 1:2500 plan NS 72/7342 copyright 1968, thence westwards and then northwestwards and following said District boundary to a point opposite the northern boundary of parcel number 6536 as shown on OS 1:2500 plan NS 70/7143 copyright of 1964, thence eastwards to and along said boundary of parcel number 6536 and continuing eastwards and following the northern boundary of parcel number 7336 then southeasterly along said boundary and north-easterly along said boundary and prolongation thereof to the western boundary of parcel number 0040, thence southwards and following the western boundary of parcel number 0040 and the southwestern boundary of said parcel (on OS 1:2500 plan NS 72/7343 copyright of 1968) and in prolongation thereof to the western boundary of parcel number 2118, thence southwestwards along said boundary of parcel number 2118 and eastwards and following the southern boundary of said parcel to the western boundary of parcel number 3400, thence generally southwards along said boundary of said parcel number 3400 (also on NS 72/7342) and in prolongation thereof to the northern boundary of parcel number 2488, thence westwards along said boundary of said parcel number 2488 to the eastern boundary of parcel number 0094, thence southwestwards along said boundary of parcel number 0094 and in prolongation thereof to the point of commencement.
